#### Background

- Summary:
  - ➤ This event will be held during the 21<sup>st</sup> session of the Human Rights Council in September 2012, marking the first Council session at which the Special Rapporteur on the promotion of truth, justice, reparation and guarantees of non-recurrence will present a report, and be engaged in an interactive dialogue during the plenary
  - The 21<sup>st</sup> session of the Council will also include the negotiation and adoption of resolutions on the right to truth (led by Argentina) and transitional justice (led by Switzerland)
