National Monitoring, Evaluation and Learning Officer – The Philippines

(Part Time Consultancy position)

The International Commission of Jurists (ICJ) is a global network of judges and lawyers united in affirming international law and rule of law principles that advance human rights.

The Asia & Pacific Regional Office is seeking qualified applicants for the position of Monitoring, Evaluation and Learning Officer based in Manila, the Philippines. The MEL Officer will be engaged to develop and/or strengthen a results-based approach to programme implementation and reporting amongst the ICJ's national partners in the Philippines.

MAIN TASKS AND RESPONSIBILITIES

- Facilitates communications between the ICJ's regional office in Thailand and partner NGOs in the Philippines on programme and finance issues.
- Guides and supports staff at partner NGOs to assess and adjust objectives, indicators and results of their individual programmes.
- Monitor and report on the progress of projects by individual partner NGOs.
- Follows up with partner NGOs on the submission of requests for payment of instalments on grants.
- Review narrative and financial reports prepared by partner NGOs before they are submitted to the ICJ.
- Support partner NGOs efforts to compile lessons learned when implementing projects.
- Support information sharing between partner NGOs and the ICJ.

QUALIFICATIONS

- Relevant university degree preferably with a post graduate qualification;
- At least three years of relevant professional experience in programme management or monitoring and evaluation functions;
- Experience with project cycle and results-based management, project monitoring, learning and evaluation and financial management of projects;
- Relevant experience managing human rights, governance and development projects is an advantage;
- Relevant work experience in the Philippines is a distinct advantage;
- Fluent in English and Filipino (written and spoken); and
- Advanced knowledge of Microsoft Office, Excel and Word-processing programmes.
