Right to life: deprivation of life by state agents; positive obligations of States; obligation of effective investigation; capital punishment.

Freedom from torture: definition of torture and other inhuman or degrading treatment or punishment; elements of torture, positive obligations of States; conditions of detention; use of force; incommunicado detention; ill-treatment of family members; positive obligations to protect and investigate allegations of torture and ill-treatment.
