Transnational Exchange Workshop on procedural rights of migrant and refugee children in legal proceedings

Brussels, Belgium 16-17 September 2025

The workshop will serve as a collaborative space to address how legal frameworks can better align with the rights of migrant and refugee children under international human rights law. Discussion will dive into the effective participation of migrant and refugee children in asylum and migration-related proceedings. Through a combination of expert-led discussions and case examples, participants will focus on legal representation and procedural safeguards through specific sessions including:

- > Legal guardianship and child-sensitive procedures
- > The role of EU institutions and legislative reforms under the new EU Pact
- > Comparative national practices and advocacy strategies

This transnational workshop will convene experts and practitioners with extensive experience working in the field of legal proceedings and child participation, including lawyers, social workers, probation officers, intermediaries, persons providing support in proceedings to children with specific vulnerabilities, judges and prosecutors from the Czech Republic, Slovakia, Malta, Austria and the Netherlands. This in-person workshop, part of a three-part transnational exchange series held in Belgium, will feed into a report serving as a practical guide for child-friendly justice and procedural rights.
