

Transnational Exchange Workshop on inclusive considerations for children with disabilities in legal proceedings

Brussels, Belgium 13-14 November 2025

The workshop will serve as a collaborative space to explore inclusive considerations for children with disabilities in legal proceedings. This workshop will focus on the barriers that children with disabilities face when participating in legal proceedings. It will explore procedural accommodations, the role of facilitators, and strategies to ensure accessibility in judicial settings. The workshop will also address how legal frameworks can better align with the rights of children with disabilities under international human rights law. Through a combination of expert-led discussions and case examples, participants will engage in specific sessions including:

- > International legal frameworks addressing disability-inclusive justice;
- > The role of intermediaries, interpreters, and disability support professionals in ensuring effective participation of children;
- > Case-law related to legal proceedings involving children with disabilities;
- > Strategies for legal professionals working with children with disabilities.

This transnational workshop will convene experts and practitioners with extensive experience working in the field of legal proceedings and child participation, including lawyers, social workers, probation officers, intermediaries, persons providing support in proceedings to children with specific vulnerabilities, judges and prosecutors from the Czech Republic, Slovakia, Malta, Austria and the Netherlands. This in-person workshop, part of a three-part transnational exchange series held in Belgium, will feed into a report serving as a practical guide for child-friendly justice and procedural rights.
